CITY OF SUNBURY Pennsylvania

A Resolution of the City of Sunbury, 225 Market Street, Sunbury, PA, Northumberland County, Commonwealth of Pennsylvania, appointing the Environmental Review Certifying Officer for the County's U.S. Department of Housing and Urban Development (HUD) funded projects.

WHEREAS, in accordance with HUD Regulations 24 CFR Part 58 and the National Environmental Policy Act, it is necessary for the GRANTEE to designate a Certifying Officer to serve as the "responsible" official to oversee the GRANTEE'S environmental requirements; and

WHEREAS, the Certifying Officer will represent the GRANTEE for environmental matters as they relate to HUD funded projects, and shall be subject to the jurisdiction of the Federal courts in the case of environmental litigation; and

WHEREAS, the Certifying Officer will assure that all environmental, procedural, and record requirements are fully and properly satisfied; and

WHEREAS, the Certifying Officer will oversee or perform all necessary functions required for environmental reviews, including consultations with all appropriate agencies directly concerned with environmental issues or having environmental responsibilities associated with the GRANTEE'S projects, and the public comment process.
