CITY COUNCIL Sunbury PA 17801 October 25th, 2021 6:15 pm

A regularly scheduled meeting of the Council of the City of Sunbury was called to order with the Honorable Mayor Karlovich, presiding (Zoom). There was a quorum with the following in attendance:

A moment of silent reflection was held prior to the beginning of the meeting.

Mayor Karlovich announced that he is attending Via Zoom due to his exposure to Covid-19 and wants to take extra precautions about it for the safety of the public and the board. Mayor Karlovich also gave an update on the requirements if exposed to Covid-19 so the public is aware of them.

PUBLIC COMMENT/AGENDA ITEMS

Mayor Karlovich asked for public comment on agenda items.

Jody Ocker: Ms. Ocker has a few comments on agenda items. Ms. Ocker wanted to bring to the attention of the board that the city clerk and city administrator ordinances both list the department they fall into as the executive department, and as far as she is aware of there is no such department and should be public affairs department. With the discussions from last meeting about the minimum wage of employees Ms. Ocker wants to make sure that these wages are sustainable in the future. Ms. Ocker noticed that revenues have been decreasing by \$100,000 dollars every year for the past several years, and unless council foresees an increase in revenue Ms. Ocker wants council to use discretion about implementing a minimum wage since wages are a must pay bill. Ms. Ocker brought up that if there is a deficit that costs will have to be cut and that could mean laying off employees or cutting services that are offered. Ms. Ocker hopes this would be in conjunction with the budget that each department would figure out what manpower they will need to operate their department efficiently such has how many full-time, part-time, seasonal employees and what they will be doing in the department. This will make it easier to predict benefits, wages, etc. for the employees to better establish the budget.

Allen Bubb: Would like a copy of the contract between the city and G&R Charles so he can review it to make sure that they are doing what they are supposed to be doing, and in the manner, they are supposed to be doing it. Mr. Bubb feels that they are taking their time and it is ridiculous. Councilman Eister responded that everyone is having trouble getting materials. Mr. Bubb said they should have had the materials on hand. Councilman Eister explained that is not true, and once the contract was signed the materials were ordered. Mr. Bubb is concerned that this work is affecting emergency responders, delivery trucks, etc. Councilman Eister explained that prior to the construction they had every agency meet and come to the site to work out new routes. Right now, they are working with the oil companies to make sure they can deliver oil to the residents. They resolved the issue with getting gas to the residences a year ago, and same with the garbage collectors.

Police Building Construction Project

Change Order #24

Councilman Reis made the motion to accept the change order of replacing old doors with new doors for a total of \$4,248. Second Eister. Unanimous vote.

PD Grand Opening

Council and City Officials disused when the grand opening date will be. An exact date was not determined.

Dimos Panagolulia: Mr. Pangolulia said that he spoke with the police officers about the April 23rd incident, and they told him to contact the Attorney General Office. He asked the mayor if he would contact the Attorney General's office with him. Mayor Karlovich said that he will provide him with the contact information but will not make the call for him.

Ed and Sue Mench: Mr. Mench brought his concerns about the Regan Street construction project. The first concern is with dump trucks blocking off sections of the road that are not closed to construction therefore making it hard for other vehicles to get through, and he mentioned that this issue was corrected. They are also concerned that the second phase of Regan Street will be dug up before the crew is done with the first phase making it impossible for anyone to get through. Councilman Eister responded that the agreement is that they will finish phase one before they start phase two.

Andy Oaks: Mr. Oaks asked at one point will they be shutting down the second street intersection? Council responded yes. Mr. Oaks is concerned that he will not be able to get tractor trailer trucks in and out of his property. Councilman Eister responded that this will not happen until spring next year, and when that time comes, they will walk the property and make modifications so you can get in and out.
