

NON-UNIFORM EMPLOYEE DISCIPLINARY POLICY AND PROCEDURE

The City of Sunbury hereby sets forth its policy relative to discipline of its employees. Oral and written warnings (see Exhibit A) and progressive or exclusive discipline, up to and including dismissal, may be administered as appropriate under the circumstances. Please note that The City of Sunbury reserves the right to terminate any employee whose conduct merits immediate dismissal without resorting to any aspect of the disciplinary process.

Group One Offenses - Procedure for Discipline

First Offense
 Second Offense
 Third Offense
 Oral counseling
 Oral Reprimand
 Written Warning

Group One Offense - Examples:

- Neglect of duty.
- Failing to report all cases of injury at once to a supervisor.
- Habitual carelessness and recklessness, playing tricks, jokes or pranks on other employees.
- Leaving an assigned work area without the knowledge and permission of a supervisor.
- Disregard for safety and comfort of fellow workers.
- Violation of established safety rules, non-use of required safety equipment, and/or not reporting of any damaged equipment to supervisor.
- Excessive tardiness and/or excessive absence.
- Insubordination and/or refusal to obey orders.
- Disorderly or immoral conduct while working for the City.
- Lying and/or deceitful conduct while working for the City.
- Release of any <u>unofficial information</u> of City government's actions to the public. <u>Unofficial information</u> is that which is being explored and being considered for any reason but has not been adopted by Council or any individual councilman and that could affect their department and cause loss of integrity or cause embarrassment to the City of Sunbury.

^{*}All personnel records shall be maintained by the City for a minimum of three (3) years.

Group Two Offenses - Procedure for Discipline

• All Offenses - Suspension with no pay as determined by Human Relations

Officer

First suspension = one (1) day Second suspension = three (3) days Third suspension = termination

(Offense discounted after one (1) year)

Group Two Offenses – Examples

- Any Group One Offense the circumstances of which are deemed by a Supervisor (or higher ranking City Official) to exceed the propriety of a punishment under Group One Offenses, but which does not rise to the level of a Group Three Offense; or,
- A fourth (4th) occurrence of a Group One Offense by an employee within a six (6) month timeframe.

Group Three Offenses - Procedure for Discipline

• All Offenses Immediate Dismissal

Group Three Offenses - Examples:

- Consumption of intoxicants while working or reporting to work under the influence of intoxicants (including, but not limited to, alcohol and/or illegal drugs).
- Failure to submit to a blood/alcohol test as required
- Deliberate destruction, theft or removal of City owned property without written consent from the supervisor
- Sexual or Discriminatory Harassment. Discriminatory harassment shall include, but not be limited to, harassment relative to race, sex, religion, national origin, color, sexual orientation, age, or disability.
- Abusive actions including verbal and/or violence
- Gross insubordination
- Misrepresenting reimbursement records i.e. time sheets, travel records for personal gain
- Removal or release, including verbal release, of confidential information

Human Relations Officer

The City Clerk shall also serve as the Human Relations Officer.

Reporting

*All reports by employees regarding disciplinary referrals shall first be made to the Department Supervisor, unless the Department Supervisor is the offending employee, in which case said employee shall report the same directly to the Human Relations Officer.

Investigatory and Decision-Making Procedure

- *All investigations relative to disciplinary actions shall be performed by the Department Supervisor, and presented thereby to the Human Relations Officer.
- **The Human Relations Officer shall perform further investigation, if necessary, and shall determine the appropriate level of discipline relative to each offense.
- ***The Human Relations Officer shall then review the chosen avenue of discipline with the offending employee, and, if the punishment therefore consists of a written warning or greater, the Human Relations Officer shall review the Disciplinary Form with said employee, who shall fill out and sign the appropriate portions of said form. The form shall thereafter be executed by the Human Relations Officer, the Department Supervisor, and the Department Head to ensure consistency and uniformity in the meting out of disciplinary actions.

Appeal Procedure

Any employee whose employment is terminated relative to any offense listed herein shall have the right to appeal said termination to a private hearing to be held before City Council, or to a public hearing before City Council if said employee so desires and provides notice of the same.

In the best interest of our employees, and in attempting to ensure the health, safety, and welfare of the same, an exception to the rule requiring automatic termination for a Group Three infraction, involving alcohol or illicit substance use, may be invoked by the City Council relative to an employee who admits the misconduct and agrees to seek immediate necessary professional rehabilitation services and comply with all recommendations thereof.

PEER-TO-PEER TECHNICAL ASSISTANCE

ARTICLES OF AGREEMENT

This agreement ("Agreement") entered into by and between the Commonwealth of Pennsylvania, Department of Community and Economic Development, Governor's Center for Local Government Services, hereinafter referred to as the "CENTER," the municipality of City of Sunbury, Northumberland County, hereinafter referred to as the "MUNICIPALITY," and an agent of the CENTER, selected and certified through appropriate training courses and hereinafter referred to as the peer-to-peer "CONSULTANT."

WITNESSETH

WHEREAS, the Municipality has requested, through action of the governing body, the services of the CENTER in providing a fire study to explore consolidation of the fire stations and six (6) fire companies and report to the Municipality's City Administrator and the elected officials on findings and recommendations.

WHEREAS, the CENTER is willing to provide the MUNICIPALITY with technical assistance through the use of the peer-to-peer CONSULTANT under the following terms and conditions:

- A. MUNICIPALITY agrees, through its officials, employees, or agents to provide the CONSULTANT with material, data and/or information determined by the CONSULTANT to be necessary for the successful completion of the project.
- B. MUNICIPALITY and the CENTER agree to permit the CONSULTANT to determine his/her hours of work and work periods so long as the total time committed to the project does not exceed hundred (100) hours.
- C. The CENTER is responsible for the wages, travel cost, and related expenses of the CONSULTANT and no cost will be assessed to the MUNICIPALITY unless assessment prohibition is waived by the MUNICIPALITY through an addendum to this Agreement, in which case the addendum shall establish the party(ies) responsible for CONSULTANT costs and expense.
- D. The MUNICIPALITY agrees to hold the CENTER and its agent, the peer-to-peer CONSULTANT harmless from any and all claims, demands, and actions based upon or arising out of any activities performed by the MUNICIPALITY employees under this Agreement and shall defend any and all actions brought against the CENTER and/or the CONSULTANT based upon such claims or demands. It is understood and agreed that the MUNICIPALITY'S standard liability insurance policies protect, or

shall be endorsed to protect, the CENTER and the CONSULTANT from claims of bodily injury and of property damage arising out of any activities or functions performed by the MUNICIPALITY, their employees, or agents under this Agreement.

- E. The CONSULTANT agrees to perform and function within the guidelines and regulations established by the CENTER and the documents composed and produced by the CONSULTANT while providing technical assistance to the MUNICIPALITY are the property of the CENTER which shall have full control over the preparation of, amendment of, final production of, and release of such documents.
- F. The CENTER shall have the right to terminate this Agreement at its convenience if the CENTER determines that termination to be in its best interest. Termination shall be effective upon written notice to the CONSULTANT. The CONSULTANT shall be paid for work satisfactorily completed prior to the effective date of the termination, but in no event shall the CONSULTANT be entitled to recover loss of profits.
