A regularly scheduled meeting of the Council of the City of Sunbury was called to order by video/teleconference with the Honorable Mayor Karlovich, presiding. There was a quorum with the following in attendance:

Mayor Karlovich made the motion to add to New Business the hire of 1 full time police officer. Second Brosious. Unanimous vote.

Mayor Karlovich made the motion to add parking cars on Walnut street extensions to house vehicles from Zimmerman's during a flood incident to discussion. Second Brosious. Unanimous vote.

APPROVAL OF MINUTES AND REPORTS

The Minutes of March 08, 22, 2021 and reports of the Fire Dept., Police Dept., Treasurer, Engineer, Code Office, and Health Dept. Reports are in the City Clerk's office for review. Minutes will be posted at <u>sunburypa.org</u>. – Mayor Karlovich motioned to approve the minutes and reports. Second Eister. Unanimous vote.

PUBLIC COMMENT/AGENDA ITEMS

Mayor Karlovich asked for public comment on agenda items.

Megan Beck: Ms. Beck wanted to make a comment on the square footage of the downtown. Ms. Beck feels that the city is lucky enough to have a downtown. Ms. Beck then went to mention the benefits it will have such as people moving to a new area, walking distance to everything, great for lower income individuals, etc. Ms. Beck mentioned that she also lived in a 360 square foot apartment before in downtown Sunbury, which allowed her to be able to walk everywhere. Being able to market that everyone can walk to places will be a huge asset to the downtown, but instead much of the downtown 2nd and 3rd floors are vacant due to the code requirements. Ms. Beck feels the square footage requirement should be reduced to what the rest of the city is since there has been no problems in the other districts.

Bob Zimmerman: Mr. Zimmerman made a comment to council saying he ran into an insurance problem with his flood mitigation plan, since he is in a flood zone. When flood issues came up in the past Mr. Zimmerman would move his lot of cars to the textile property, but Drive the new owners said that he has to bring it up to them during the time of the emergency. Mr. Zimmerman said that floods from the river and creek can come up within hours, and it is not possible to get approval days ahead of time. Mr. Zimmerman said that in 60-90 days a new owner might be owning part of the textile mill and will work with Mr. Zimmerman about parking his cars. He now has concerns about areas he can park his cars during a flood until he can find a different location to park, and he needs a designated area to park to get insurance. The Walnut street extension is a good place to temporally park cars. Mr. Zimmerman mentioned that he only had to move his 100-plus number of cars off his lot once in 20 years, and that was back in 2011. Mr. Zimmerman is requesting that he be allowed to park his cars on walnut street during a flood emergency.

Councilman Brosious asked Ms. Beck a question regarding to where the residents will park in the downtown. Ms. Beck responded that there is multiple city lots nearby and that people who live in the downtown will be able to use a bike to travel.

Mayor Karlovich made the motion to lower the requirement to 400 square feet minimum so long as it meets all other code requirements. Second Reis. Unanimous vote.

Career Link Lease Renewal

Councilman Reis made the motion to extend the contract with permission to have Joel make an extension agreement for them to sign. Second Eister. Unanimous vote.

Appointment of Andre Manresa To Planning Commission

Mayor Karlovich made the motion to appoint Andre Manresa to the planning commission. Second Eister. Unanimous vote.
