WHEREAS, In 1972, the Autism Society launched the first annual National Autistic Children's week, which evolved into Autism Acceptance Month and in 2008, the United Nations General Assembly declared April 2nd as World Autism Awareness Day to highlight the need to help improve the quality of life of those with autism; and

WHEREAS, autism spectrum disorder is a developmental disability that can cause significant social, communication, and behavioral challenges. Those with autism may communicate, interact, behave, and learn in ways that are different from neurotypical people. The learning, thinking, and problem-solving abilities of people with autism can range from gifted to severely challenged; and

WHEREAS, autism is the fastest growing developmental disorder. The Centers for Disease Control and Prevention reports that one in 44 children have been identified with autism spectrum disorder with boys being four times more likely than girls to be diagnosed; and

WHEREAS, there is currently no cure for autism spectrum disorder, however, research shows that early intervention treatment efforts provide the best opportunity to support healthy development; and

WHEREAS, the individuals with Disabilities Education Act (IDEA), the nation's federal special education law makes available a free appropriate education to eligible children with disabilities; and

WHEREAS, in the law, congress states, disability is a natural part of the human experience and in no way diminishes the right of individuals to participate in or contribute to society. Improving educational results for children with disabilities is an essential element of our national policy of ensuring equality of opportunity, full participation, independent living, and economic self-sufficiency for individuals with disabilities; and

WHEREAS, we honor those past and present who have autism spectrum disorder, the medical professionals, family members and advocates; and

NOW THEREFORE, I, Joshua A. Brosious, Mayor, on behalf of the City Council of the City of Sunbury, do hereby recognize Autism Acceptance Month and urge the community to recognize Autism Acceptance Month.

WHEREAS, Every day in America, more than 200 individuals are shot and wounded and more than 110 are killed by gun violence (resulting in an average of nearly 16,000 gun homicides every year), Americans are 26 times more likely to die by gun homicide than people in other high-income countries;

WHEREAS, In Pennsylvania, there are an average of 1,628 gun deaths every year, with a rate of 12.4 deaths per 100,000 people, thereby having the 31st highest rate of gun deaths in the US;

WHEREAS, Gun homicides and assaults are concentrated in more densely populated areas, with more than half of all firearm related gun deaths in the nation occurring in 127 cities. Communities across the nation, including City of Sunbury, are working to end the senseless violence with evidence-based solutions;

WHEREAS, Gun violence prevention is more important than ever as the COVID-19 pandemic continues to exacerbate gun violence with more than two years of increased gun sales, increased calls to suicide and domestic violence hotlines, and an increase in city gun violence;

WHEREAS, Mayors and law enforcement officers know their communities best, are the most familiar with local criminal activity and how to address it, are best positioned to understand how to keep their citizens safe, and are dedicated to protecting public safety in the communities where we serve;


WHEREAS, Support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with keeping guns out of the hands of children and away from people with dangerous histories;

WHEREAS, the citizens of Pennsylvania recognize the need for osteopathic physicians who are committed to improving the health of all Americans;

WHEREAS, In January 2013, Hadiya Pendleton was tragically shot and killed at age 15.
