Mayor Brosious made the motion to accept the resignation of Victoria Rosancrans from the DEI Office. Second Reichner. Unanimous vote.

ZITO Pole Placement

Councilman Eister made the motion to allow ZITO to place a pole close to the PPL substation. Second Reichner. Unanimous vote.

Non-Uniform Pension Service Agreement between City and Siegel

Councilman Reichner made the motion to accept the service agreement. Second Brosious. Unanimous vote.

Allocate Benecon Surplus

Councilman Reichner made the motion to add Benecon surplus check to the agenda. Second Brosious. Unanimous vote.

APPROVAL TO PAY INVOICES

Councilman Reichner moved to approve to Pay Invoices/Vouchers General Fund - \$117,885.56 and Liquid Fuels Fund - \$6,079.03, which includes the Bencon Surplus check being paid towards the PD Building Loan. Second Eister. Unanimous vote.

Amending Chief of Police Overtime Clause

Mayor Brosious made the motion to accept the amendment to the chief of police overtime clause until the end of year. Second Barnhart. Unanimous vote.

Discussion

There was discussion regarding the following topics between council and public officials.

- Parking Meters
 - o There was discussion regarding purchasing new parking meters for the city.
- Promotional Banner Program
 - Mayor Brosious mentioned that he spoke with a vendor regarding getting banners similar to the hometown heroes banners that will help to promote the businesses in Sunbury, and this program will be no cost to the city. Council then proceeded to discuss the topic.

Pre-Submitted Audience Comment

There were no Pre-Submitted Comments.

In Person

Mayor Brosious asked for public comments.

Melissa Rowse: Ms. Rowse wanted to make a suggestion that for the banners that the Think Sunbury logo should be at the bottom, so they are all uniform.

Victoria Rosancrans: Ms. Rosancrans wanted to bring to council's attention that she received a message about having a protest in Cameron park. Ms. Rosancrans mentioned that she directed the person to City Hall to help them reserve the date. Ms. Rosancrans then asked what is the law and what does a group have to do to have a protest in the park. Chief Hare and Councilman Reichner responded that they would just have to get a permit through the code office.

Lindie Lloyd: Ms. Lloyd feels that since it is a public park that it should be allowed for people to hold a sign. Mayor Brosious responded that having a few people holding signs is one thing and having a couple hundred people is a different thing and the best route would be to go through the code office. Ms. Lloyd had another question for council that she thought of during an event she organized on Saturday at the riverfront park. She was wondering if the city thought about buying domes or fan sail to allow people to utilize the park during hot weather.

Victoria Rosancrans: Ms. Rosancrans was wondering if the City was utilizing and apart of the chamber of commerce it Milton. Mayor Brosious mentioned that the City is only apart of the chamber of commerce located in Shamokin Dam. Ms. Rosancrans mentioned that she would hope that the City would reconsider joining the commerce in Milton to help promote the businesses in the City.
