Ms Koonsman feels that this grant is a joke because she received quotes to paint her building and they range from \$20,000 to \$40,000 and the grant only covers \$5,000. Mayor Brosious explained that is the State's guidelines where it is a 50/50 percent match up to \$10,000. Ms. Koonsman wanted to know where does the additional help come from. Ms. Koonsman asked if the City has missed any grants that could help the businesses. City officials mentioned that they didn't miss any grants that the city must apply but mentioned that there are many grants that could apply for themselves. City officials also mentioned that sometimes they see grants that could apply for businesses and they forward it to them via email.
