- 2. Fill out application and submit to Code office representative. With all forms completed and all required information submitted

Required information: 2 Forms of Identification

A VALID Driver License or Photo Identification card.

SOCIAL SECURITY CARD
RECENT BILL IN APPLICANT'S NAME
PASSPORT
STATE ISSUED IDENTIFICATION OF ANY FORM

Additional Required information:

Must supply Code office with any pamphlets or business material that agents will be distributing within the Municipality.

- 3. Review this sheet and read the City of Sunbury Code ordinance Section 124 (attached).
- 4. A file will be created for each agent applying and held at the City of Sunbury Code office.
- 5. All Applicants shall have a background check performed at the Sunbury Police Department.
